The Curriculum

In Kingsmills Primary School our aim is to provide a broad and balanced curriculum, which is the entitlement of each child. This year we placed particular emphasis on spelling, measures, assessment and ICT. These were integrated into our Development Plan and a positive impact was observed on analysis of assessment results.

Extra Curricular

The arrangement of after school clubs has allowed as many opportunities as possible for the children. The children take part in a variety of after school clubs such as football, hockey, cycling proficiency, art, music and cookery. We believe this to be an important part of their education as it allows children to fully express themselves and gain success in things non-academic.

Special Needs

All staff members complied with the aims of the Special Needs Policy and worked as a team to raise self-esteem and the education levels of the children concerned. A part-time member of staff continues to be used to reduce class sizes. The children who required individual teaching have Individual Education Plans (IEPs) showing their learning targets. Parents are frequently consulted and plans are reviewed. Children are withdrawn once a week for one to one teaching. A classroom assistant was given

extra hours delegated from the school's LMS budget to allow for one to one and group work.

Maintenance and Safety

The Governors and staff continue to oversee the security provisions for pupils and staff at school and the school premises. All electrical equipment is tested on a regular basis. The Principal raised a number of issues with EA regarding maintenance and safety. The majority of these have been resolved satisfactorily, to provide a safer environment for the children, staff and visitors.

Child Protection

Kingsmills Primary School Child Protection Policy is available to view in paper copy upon request. Child Protection procedures continue to be fully implemented and criminal background checks are carried out on all newly appointed staff and volunteers. Mrs Scroggie is the designated teacher for child protection and Mrs Courtney is the deputy designated teacher for child protection. Both Mrs Scroggie and Mrs Courtney have attended appropriate training in child protection procedures.

Child Protection matters are reported regularly to Governors at each meeting.

End of Key Stage Results 2020/21

These results are based on assessment activities, samples of work and progress made during the year.

Standardised Tests:

Evidence is gathered and analysed from the results of standardised tests in Literacy and Numeracy from Primary 2 to Primary 7 (and on occasions in Primary 1). The formal assessment instruments that are employed include Middle Infant Screening Test (MIST), GL Baseline, CAT4, Progress Through English (PTE) and Progress Through Maths (PTM) and SWST. Standardised test results enable teachers to identify specific strengths and weaknesses and so plan for future teaching and learning. This evidence may also be used to provide information about the work of a particular pupil in order to ensure that sufficiently challenging goals are set or, conversely, to indicate that the pupil's name should be placed on the Special Needs register, as he/she requires additional support.
